Mr. Wang will be the Head of Human Resources for the Group. He will be based in Yangon. Mr. Wang has 23 years' experience in human resource management including 16 years in varied regional leadership roles. He has lived and worked in Singapore, Hong Kong, Shanghai, Beijing and Bangkok. His previous appointments were with major global corporations including Fedex, BOC Gases, Caltex Oil, Reader's Digest and Bacardi. Mr. Wang is also a published author and a frequent public speaker on human resource issues.

Mr. Wang holds a MBA from the University of Bath, UK and is a scholarship sponsor of his alma mater.



## (c) Ms Jane Kwa ("**Ms Kwa**")

Ms Kwa will be appointed as the Head of Investor Relations for the Group. She will initially be based in Singapore and she will be responsible for all investor relations matters. Ms. Kwa spent 8 years in the real estate industry specializing in property analysis and financial modeling. She was an equity analyst with DBS Vickers from Sept 2010 to April 2013, covering the companies in the commercial real estate investment trust sector.
